Privacy Policy

CUBIQX is committed to the protection of the personal information of individuals. Our privacy policy sets out the principles we will adopt in the management of personal information.

1. Collection of Personal Information

Personal information is generally defined as information or an opinion that can identify a person. - where CUBIQX is required or authorised by law to do so; or
- with your consent.

CUBIQX may collect "clickstream" information (such as areas of our website you have accessed and the time and date of access) from an individual's use of our website.

We may also store "cookie" information, such as user preferences relating to the use of our websites. A cookie is a small data file that may be placed on the computer of a web user (usually in the browser software folder). The information collected is used to customise and improve our websites. If you do not want us to store cookie information on your computer, you can set your browser to disable this feature. This may mean you will not be able to take full advantage of CUBIQX's services offered on our website.
